Vice-Rector for Research: Corvinus University of Budapest (2019-2022)

Held leadership responsibilities for increasing international research visibility of Corvinus faculty (500+ faculty members) by designing and implementing new performance measurement and incentive systems. Developed a streamlined process for establishing, positioning and evaluating Corvinus journals, facilitated the research agenda of Corvinus research institutes, developed a process of hosting international conferences, restructured the system of international research grants, played an integral role in introducing the tenure-track system at Corvinus, oversaw the restructuring of the Doctoral Schools of Corvinus, chaired the Committee on Research Ethics, and contributed to Corvinus' achieving AACSB accreditation.

Direct reports included Director of Corvinus Doctoral Schools (an umbrella organization for the administration of doctoral affairs with 4 people plus one of the Heads of the four Doctoral Schools), Directors of Corvinus Research Centers (5), Editors-in-Chiefs of Corvinus Journals (3), Director of the Office of External Research Projects, Director of Corvinus Libraries, Director of Corvinus Archives, and Office of the Vice-Rector for Research (4).

Based on international standards, developed a system of detailed and fine-grained quality assessments for publications of all full-time and part-time faculty members.

Under his leadership, the score of quality academic publications (weighted by the quality of publications and the number of authors) grew about 50% from 2019 to 2022.

• *Corvinus Research Excellence Awards* (with the requirements, process of evaluation, international judges, and awards); in 2021, there were 33

awardees from 52 applicants in excess of HUF 80 million, in 2022 there were 64 awardees from 80 applicants with about HUF 94 million award money.
